**CAWCD Firming Agreement** 

#### **ISSUE SUMMARY/DESCRIPTION:**

All deliveries of water in the CAP system require some form of water delivery contract, and the CAWCD Firming Water Delivery Agreement (Agreement) can serve this role for water that is delivered to supplement (firm) a CAP M&I subcontract (M&I or NIA priority) that has been reduced in shortage. This Agreement is contemplated in Article 8 of the 2017 CAP System Use Agreement (SUA) between CAWCD and Reclamation, and section 8.4 of the SUA provides for Reclamation to develop a similar agreement for firming Tribal contracts.

The most common expected use of this Agreement is for M&I priority subcontractors that elect to have CAWCD provide Firming Water on behalf of the Arizona Water Banking Authority (AWBA). CAWCD can develop Firming Water in several ways, including recovering (pumping) Long-Term Storage Credits transferred from the AWBA utilizing a partner's permitted recovery wells and then exchanging that supply for CAP water; exchanging credits for CAP water supplies held by the CAGRD; or directly discharging recovered water into the CAP aqueduct. The CAWCD Firming Water Delivery Agreement is the contractual mechanism for the M&I subcontractor to receive that water, and contains the same basic provisions contained in the subcontract itself (e.g., scheduling, no warrantee of water quality, etc.). The Agreement is also written to cover situations where a CAP M&I subcontractor has developed their own supply that they wish to have delivered through the CAP system exclusively for firming. In that case, the Agreement can serve in place of a CAWCD or Reclamation Wheeling Contract (as those are defined in the SUA).

This Agreement has undergone a number of revisions in response to stakeholder comments. In particular, efforts have been made to clarify the relationship between the Agreement and other provisions of the SUA, now included as an exhibit, and noting that the scope is limited to the terms and conditions for the receipt of Exchange Water or non-Project Water delivered via the CAP system for firming. The particular means by which those supplies are developed falls outside the scope of this agreement, and to further emphasize the purpose of the document, the words "water delivery" were added to the title.
