**A RESOLUTION RECINDING AWARD SOLE SOURCE CONTRACT TO BARKHOUSE  
IN THE AMOUNT OF \$185,000 TO PROVIDE SERVICES THAT WILL REDUCE THE  
ANIMAL POPULATION IN DOÑA COUNTY**

**WHEREAS**, the Board of Commissioners of Doña Ana County approved the request to award sole source contract to Barkhouse in the amount of \$185,000 to provide services that will reduce the animal population in Doña Ana County on March 23, 2021; and

**WHEREAS**, the Board of Commissioners was presented with testimony from Jeanne Quintero, Interim Animal Control and Codes Manager, at 9:47am, March 23, 2021, that she was provided a Proposal by Kelly Barker, “which she was trying to get someone to fund” ; and

**WHEREAS**, § NMSA 10-16-13 – Public Officers and Employees, Conduct, Prohibited Bidding, states;

“No state agency or local government agency shall accept a bid or proposal from a person who directly participated in the preparation of specifications, qualifications or evaluation criteria on which the specific competitive bid or proposal was based. A person accepting a bid or proposal on behalf of a state agency or local government agency shall exercise due diligence to ensure compliance with this section.”

;and

**WHEREAS**, § NMSA 10-1-102 – Competitive Sealed Bids Required, states;

“All procurement shall be achieved by competitive sealed bid pursuant to Sections 13-1-103 through 13-1-110 § NMSA 1978, except procurement achieved pursuant to the following sections of the Procurement Code: .....” suggests, that prior to approval of the Sole Source, this proposal would have been treated as a competitive bid; and

**WHEREAS**, Barkhouse is not currently registered with the New Mexico Secretary of State as either a licensed organization or a “DBA” of either Barkworks, Inc. nor Unchained Paws, Inc.; and

**WHEREAS**, the sole source procurement was approved for an organization that is not currently nor ever has been recognized by the State of New Mexico; and

**WHEREAS**, the Board of County Commissioners is bound to follow state procurement statutes; and

**THEREFORE, BE IT RESOLVED:** that Doña Ana County Board of County Commissioners hereby rescinds the awarded sole source contract to Barkhouse in the amount of \$185,000 to provide services that will reduce the animal population in Doña County ; and

**BE IT FURTHER RESOLVED:** The central purchasing office begin the process of publishing this proposal for public bids.
