AMENDMENT #2 TO MASTER SERVICES AGREEMENT

This Amendment to the Master Services Agreement (the "Amendment") is made and entered into by and between Healthstat, Inc., a North Carolina Corporation ("HS") and Forsyth County, GA, a county and political subdivision of the State of Georgia ("County").

WHEREAS, HS and County executed a Master Services Agreement (the "Agreement") dated effective May 2, 2019 and have mutually agreed to amend the Agreement as set out herein.

NOW, THEREFORE, in consideration of the premises and the mutual covenants contained herein and, in the Agreement, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

Effective January 1, 2022 ("New Pricing Effective Date"):

Section X of Exhibit "B.1": NEW CLINIC PROGRAM is hereby amended as follows:

B. Program Administration Fees.

• The Program Administration Fee will increase by <u>3%</u> from <u>\$11,844.74</u> per month to <u>\$12,200.08</u> per month based on up to a maximum of <u>4,100</u> monthly Clinic Participants. This will represent the 3% annual increase for 2022, as called for in the Master Agreement.

C. Clinic Staffing Rates.

- *Nurse Practitioner Hourly Fee.* County shall pay Healthstat an hourly rate to staff the Clinic with a Nurse Practitioner (presently Eva Willauer). As of the New Pricing Effective Date, the hourly rate due for this position shall increase by <u>3%</u> from <u>\$95.53</u> per hour to <u>\$98.40</u> per hour for an estimated <u>40</u> hours per week. This will represent the 3% annual increase for 2022, as called for in the Master Agreement.
- *Medical Office Assistant Hourly Fee.* County shall pay Healthstat an hourly rate to staff the Clinic with a Medical Office Assistant (presently Connie Gravley). As of the New Pricing Effective Date, the hourly rate due for this position shall increase from <u>\$31.00</u> per hour to <u>\$31.93</u> per hour for an estimated <u>40</u> hours per week. This will represent the 3% annual increase for 2022, as called for in the Master Agreement.

Exhibit "B.2": CENTRAL APPOINTMENT SCHEDULING LINE is hereby amended as follows:

• The Central Appointment Scheduling Line Fee will remain at the rate of <u>\$1,386.64</u> per month.

Exhibit "B.4": AFTER HOURS PROGRAM is hereby amended as follows:

 The After-Hours Program service will remain in effect. However, Healthstat agrees that County will pay <u>\$0.00</u> for this service effective January 1, 2021, through March 31,2022. Effective April 1, 2022, through December 31, 2022, this fee shall increase to <u>\$2,311.06</u> per month (a 3% increase) over the original <u>\$2,243.75</u> per month fee stated in the Master Agreement). At the beginning of each successive term (starting January 1, 2023), this fee shall automatically increase by 3%.

The terms and conditions of the Agreement shall remain in full force and effect except as expressly amended hereby.
