**AN ORDINANCE AMENDING SECTION 2-A, SECTION 3-C, SECTION 5-C OF ORDINANCE 3089, ADOPTED JULY 17, 2012 DESIGNATING THE POLLING PLACES TO BE CHANGED FOR THE PRECINCTS KNOWN AS THE HIGHLAND PRECINCT, East 6<sup>th</sup> STREET USO CLUB PRECINCT AND THE KAMPER PARK PRECINCT IN THE CITY OF HATTIESBURG, MISSISSIPPI.**

**WHEREAS**, the governing authorities of the City of Hattiesburg, Mississippi, find that the polling places known as Highland Park Precinct, East 6<sup>th</sup> Street USO Club Precinct and the Kamper Park Precinct, as adopted and approved by Ordinance 3089, on July 17, 2012 is not suitable for the municipal elections; and

**WHEREAS**, the governing authorities of the City of Hattiesburg, as authorized by Section 23-15-557, Mississippi Code of 1972, as annotated and amended, find that the location of the polling place for the Highland Precinct located in Ward 1 should be moved to the Longleaf Trace Precinct located at 2895 West 4<sup>th</sup> Street, Hattiesburg, Mississippi: and

**WHEREAS**, the governing authorities of the City of Hattiesburg, as authorized by Section 23-15-557, Mississippi Code of 1972, as annotated and amended, find that the location of the polling place for the East 6<sup>th</sup> Street USO Precinct located in Ward 2 should be moved to the Eureka School Precinct located at 412 East 6<sup>th</sup> Street, Hattiesburg, Mississippi: and

**WHEREAS**, the governing authorities of the City of Hattiesburg, as authorized by Section 23-15-557, Mississippi Code of 1972, as annotated and amended, find that the location of the polling place for The Kamper Park Precinct located in Ward 4 should be moved to the Hardy Street Precinct located at 1610 Hardy Street, Hattiesburg, Mississippi.

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HATTIESBURG, MISSISSIPPI:**

**SECTION 1.** That based upon the finding of facts as set out hereinabove, the governing authorities do hereby amend Section 2-A, Section 3-C and 5-A of Ordinance 3089, adopted July 17, 2012 and direct that the hereinabove polling places be changed.

**SECTION 2.** That the governing authorities of the City of Hattiesburg, Mississippi further direct the City Clerk cause to have published in a newspaper of general circulation within the city, on three (3) occasions a notice of such size and content as to call attention to voters of this change and that the City Clerk be further directed to notify every registered voter in the Highland Precinct, East 6<sup>th</sup> Street USO Precinct and the Kamper Park Precinct, by mail, and to have affixed the appropriate places and signs sufficient to direct voters to the appropriate polling place.

**SECTION 3.** That this Ordinance take effect and be in force thirty (30) days from and after passage as provided by law.
