AN ORDINANCE AUTHORIZING AN AMENDMENT TO THE PLANNING PROGRAM IN THE GENERAL FUND AND EXECUTION OF AN AGREEMENT WITH ST. JOSEPH COMMUNITY ALLIANCE TO CONTRIBUTE TO THE COST OF A FEASIBILITY STUDY FOR DEVELOPMENT OF A POTENTIAL ATHLETIC COMPLEX ALL IN THE AMOUNT OF \$20,000.00.

WHEREAS, the City of St. Joseph desires to contribute to a feasibility study for development of an athletic complex in collaboration with other members of the Community Alliance; and

WHEREAS, a Facilities Feasibility Study will be used as a tool to help serve as a vision and guide for the development of an athletic complex; and

WHEREAS, the Community Alliance will work with consultants to create a plan to help to determine the opportunity for development of a facility to increase and promote sports recreation as a local amenity and a tourism attraction.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ST. JOSEPH, MISSOURI, AS FOLLOWS:

SECTION 1. That the Agreement by and between the City of St. Joseph, Missouri, and St. Joseph Community Alliance for design and planning work related to the creation of a Facilities Feasibility Study in the amount of \$20,000.00, be and hereby is, approved and that a true and accurate copy of said agreement is attached hereto and incorporated herein by reference as though fully set out herein.

SECTION 2. That the City Manager be, and hereby is, authorized to execute said Agreement with St. Joseph Community Alliance, in substantially the form as that attached hereto, by and on behalf of the City of St. Joseph, Missouri, and is further authorized to sign all necessary documents, amendments, and addenda thereto which may subsequently be required to effectuate the purpose and intent of this Agreement.

SECTION 3. That the General Fund, Planning Program budget be, and hereby is, amended for Fiscal Year 2022-2023 as follows:

SECTION 4. That the Finance Director be, and hereby is, authorized to effect such budget amendments upon the financial books of the City, to issue a warrant in payment thereof pursuant to the aforesaid agreement and to charge \$20,000.00 to the Fiscal Year 2022-2023 General Fund Planning Program, Account Number 5110-1495 (Special Contribution) when directed to do so by the Director of Planning and Community Development.

SECTION 5. That this ordinance be, and hereby is, effective upon passage.
