

**BILL # 211-22****AN ORDINANCE AUTHORIZING AN AMENDMENT TO THE PUBLIC HEALTH DEPARTMENT BUDGET IN THE GENERAL FUND TO ROLL OVER UNSPENT FUNDS IN THE AMOUNT OF \$812,210.11 FROM A VARIETY OF GRANTS AND CONTRACTS.**
