Fiscal Year 2024 Water & Sewer Rates

As a follow up to the memorandum provided to you on June 13th regarding the Fiscal Year 2024 Water & Sewer Rates, may I provide the following information:

Background

A water and sewer rate study was conducted to provide the City with recommended water and sewer rate changes which will generate sufficient revenue to fund the operational, indirect, debt service and short term and long-term capital improvement costs, while ensuring the enterprise funds continue to maintain healthy retained earnings.

Proposed Rates and Charges

In order for the City to target a healthy retained earnings of 15% by FY2028 a water rate increase of 5.5% and a sewer rate increase of 6% would need to be applied in FY 2024. However, if the City chooses to utilize funds from the American Rescue Plan Act ("ARPA") to the water and sewer enterprise funds to finance infrastructure improvement projects in FY 2024 and FY 2025, a mid-year rate adjustment can be performed to decrease the rates in line with Option 2 in the June 13, 2023 memorandum.

Assuming the above, the quarterly water bill for a usage of 1,800cf will increase \$5.61 per quarter, from \$101.95 to \$107.56. The quarterly sewer bill for a typical resident with a usage of 1,800cf will increase \$11.28 per quarter, from \$187.92 to \$199.20. The overall or combined water and sewer bill for a typical resident with a usage of 1,800cf would increase from \$289.87 per quarter to \$306.75 per quarter; for an overall increase of \$16.88 per quarter, or 5.8%.

Tables 1 and 2 below present the current and proposed water and sewer rates, as well as quarterly bill impacts for typical customers, respectively.
